

General regulations participants L.C.N.-show



1. The organization is in the hands of the Landbouwminiaturen Club Nederland.
2. Collector and traders are allowed on Saturday and Sunday.
3. Stand rental sales tables; € 45.- per table per day, € 60.- per table for two days.
For the show tables, there will be a fee of € 7,- per table. If you bring your own tables or constructions, no fee will be charged.
4. The tables are assigned by the organization.
5. It is no one allowed to put his assigned place at someone's disposal or to sell things on behalf of someone else without permission of the organization.
6. Participants cannot hold the organization responsible for damages to, theft of, fire or damage in any kind, from goods destined for the show.
7. As soon as the show is open to the public, no goods can brought in.
8. All stands have to be arranged before 9.30 a.m. Participants to the show have the opportunity to bring in their goods on Saturday between **6.30 and 9.00 a.m.** and at Sunday from **8.00 till 9.00 a.m.**
9. There are no chairs available at/behind the stands.
10. It is not allowed to install electric wiring oneself.
11. The power outlet point is to be used for charging laptops, telephones or for using payment equipment. The use of large consumers such as water cookers, coffee machines etc. is not allowed.
12. Cars / trailers are not allowed in the hall for buildup / break down and sales /show stand. (because of floor covering).
Goods for setting up the stand may be brought into the hall by the use of trolleys or hand trucks only through the entrance doors of the hall. Bringing these items in through the main entrance of the building is not allowed.
13. During the show the stand has to be occupied by at least one person at all times.
14. It is not allowed to place and/or add own tables or goods next to or in front of the stand respectively in the lanes
15. For private collections that are on display in the showcases of the association, there is taken out an insurance policy at a maximum of € 7000,- per showcase.
16. The building is guarded outside of build-up and opening hours. During the show, the emergency doors are also equipped with security.
17. It is only allowed to sale or trade **agricultural miniatures and collectors objects related to agriculture** like literature and pins, etc. So no cars, trains, etc. At violation you will be removed from the show. A specific definition what is allowed and what not can you read in the enclosed "Rules standholders and showtables L.C.N.-show".
18. For traders with a combination of a part for sales and a part for display it is forbidden to offer material for sales on the tables for display. Tables for display are not meant as promotion for the sales program.
19. All commercial rights for this event belong to the organization. Advertising, or distributing of advertising material for companies other than standholders, political organizations etc. is forbidden.
20. Cancellation has to be done in writing 14 days before the show at the very latest (the already paid amount minus € 5.- administrative costs will be refunded). At cancellation within 14 days before the show you cannot claim the registration money paid by you.
21. Participants are compelled to follow the directions given by or on behalf of the organization.
22. The regulations are applicable to all participants.
23. Pets are not allowed during the show, excepted 'help dogs'..
24. **All registrations will be processed in order of entries at www.beurs@agritoy.nl. Full is Full. You are only registered after payment of the rent, per bank.**

25. Wristbands that are used as admission ticket for the show will be distributed after enrolment at the organization on Saturday in the hall. No wristband means no admittance. Number of persons behind the stand has to be mentioned in the registration form.
Per stand 2 wristbands free, additional wristbands €10,- p.p.
26. Number of persons allowed per table: 1 (first) table 2 persons and each table more 1 person per table.
27. Participants are at the show at their own risk and are responsible themselves for insuring the products displayed by them.
28. In all cases these regulations do not foresee, the organization decides.
29. The use of sand or other materials on the floor is only permitted if the floor is covered with a proper (thick) shield. And provided if the location after the show is left 'broom swept'.
30. Cardboard, paper and waste must be taken home by the participants themselves. The stand must be left 'broom swept' afterwards.
31. Opening hours for visitors on exhibition days :
Saturday 10:00- 17:00 and Sunday 10:00- 16:00
32. Emergency exits always have to stay open, because of each other's safety. This will be checked.
