

General regulations participants L.C.N.-show



- 1) The organisation is in the hands of the Agricultural Miniatures Club Netherlands.
- 2) Collectors and dealers are allowed on Saturday and Sunday.
- 3) Stand rental for sales tables is €40.00 per table per day, €60.00 per sales table for two days. These amounts are exclusive of 21% VAT.
- 4) Stand rental for show tables is €6.50 per table per day. This amount excludes 21% VAT.
- 5) Stand locations will be allocated by the organisation.
- 6) No one is allowed to make the allocated stand space available to another person or to sell his/her goods on behalf of another person without permission of the organisation.
- 7) Participants can never hold the organisation responsible or liable for damage to, theft of, fire or damage of any kind to the goods destined for the show.
- 8) As soon as the show opens to the public, no goods may be brought inside.
- 9) All stands must be set up by 9.30 am. Participants in the show have the opportunity to bring in their goods for this purpose on Saturday between 6.30 and 9.00 am. On Sunday from 8 a.m. to 9 a.m.
- 10) It is forbidden to place goods in front of or next to the stands and in the walkways.
- 11) It is not allowed to install electrical cords yourself.
- 12) The power point is for charging laptop, phone or use of payment equipment. Use of large consumers such as kettles, coffee machines, etc. is not allowed.
- 13) A power point consists of a single socket. From 2025, this is different from previous years where 3 sockets had to be taken immediately. The price has been adjusted accordingly. Extension cords or cable reels with multiple sockets may not be used. If more power outlets are required, please order multiple power points.
- 14) Cars / trailers are not allowed in the hall for construction / dismantling and sales / show stand.
- 15) During the show, the stand must be occupied by at least 1 person at all times.
- 16) It is not allowed to place and/or add own sales tables next to or in front of the stand. However, show tables may be own tables - e.g. for placing a diorama.
- 17) For private collections exhibited in the showcases of the association, the exhibited models are insured at the daily value of the models.
- 18) The building is guarded outside set-up and opening hours. During the show, the emergency doors are also equipped with surveillance.
- 19) It is only allowed to offer agricultural miniatures and agricultural related objects such as literature and pins, etc. for sale or exchange. So no cars, trains, etc. In case of violation, you will be removed from the show. A specific description of what is and what is not allowed can be read in: Regulations exhibitors and show tables L.C.N. show.
- 20) Traders with a combination of sales and show section are forbidden to offer material for sale on tables of the show section. Show tables and showcases are not meant for promotion of the sales programme.
- 21) All advertising rights for this event are reserved to the organisers. Advertising, propaganda or distribution of advertising material for companies other than exhibitors, political organisations etc. is prohibited.
- 22) Cancellation must be made in writing no later than 14 days before the show (stand rent already paid minus €5.00 administration fee will be refunded). In case of cancellation within 14 days before the show, you can no longer claim the registration fee you paid.
- 23) Participants are obliged to follow instructions given by or on behalf of the organisation. These regulations apply to all participants.
- 24) Pets are not allowed during the show except for assistance dogs.
- 25) You are registered after debiting the amount due from the bank.
- 26) Wristbands that serve as entry tickets for the show will be issued after registering with the organisation, on Saturday in the show hall. No wristband means no entry. Please state the number of persons behind the stand on the registration form.
- 27) Number of persons allowed per stand: 1 (first) table 2 persons and each table more 1 person per table. On payment/reservation. **The total stand rental includes 2 wristbands, additional wristbands €10,- p.p.**
- 28) Participants are on their own responsibility and are responsible for whether or not the products they display are insured.

- 29) In all cases not covered by the regulations, the organisation will decide.
- 30) Opening hours for visitors on the show days: Saturday 10:00- 17:00 and Sunday 10:00- 16:00.
- 31) As an exhibitor, your stand will remain available to visitors until the end of the show. It is therefore not allowed to break down your stand during the opening hours of the show.
- 32) The emergency exits and fire extinguishers must remain clear for everyone's safety. This will be checked.**

THE TABLES MEASURE 160 X 80 CENTIMETERS

As of 2023, it is unfortunately not possible to set up on Friday afternoon/evening as standard.

Should it nevertheless be possible to set up on Friday, the trade show committee will let exhibitors know by e-mail. This information is only known shortly before the show and depends on the availability of the halls.

The earlier limitation on the number of people during the build-up on Friday afternoon is thus lifted.

From Saturday morning at 6.30 am, exhibitors can enter with the number of people specified in advance*.
